(Dispersal of Rab'a Sit-in and
Relevant Reports)

Nasr City First Police Station

The Report is recorded on 14/8/2013

In the context of the sit-in of the Muslim Brotherhood (MB) in Rab'a Square and the surrounding area, including Al-Tayaran St, Al-Nasr Road, and Yousef Abbas St starting on 28 June and for 47 days; they blocked the road, hindered traffic, and shut a number of government and public installations (such as Nasr City Traffic department, Traffic General Department, Port Security Directorate, Arab Bank, Tiba Mall, and many other stores). They also hindered the flow of work in many institutions (like Greater Cairo Project Development Agency), tortured many citizens, and verbally and physically assaulted and terrorized others, causing injuries to them.

Upon the decision of the Public Prosecutor regarding the report written by the Public Security Sector on the sit-ins in Rab'a and Nahda and other squares; after the existence of evidence of sabotaging and causing damage to state institutions, looting the said buildings, acts of killing, resisting authorities, and conducting acts of physical torture and detention with the purpose horrifying and terrorizing the citizens, the Public Prosecutor ordered that the police report on the crimes committed in Tahrir, Nahda, Rab'a, and other squares where the said crimes were committed. He also ordered the retrieval of the broadcast vehicles the perpetrators seized and arresting:

- 1- Mohamed Badei;
- 2- Mohamed Al-Beltagy;
- 3- Safwat Hegazy;

4- Hassan El-Brens; and

5- Bassem Ouda.

He also issued an arrest warrant against the Islamic Group figure Tareq Al-Zomor. The Council of Ministers and the Defense and National Security Council authorized the police to end the sit-in in conformity with the state laws. Accordingly, today, a joint force of the police and the army was formed. When the force reached the location of the sit-in, the following procedures were taken:

- 1- The protestors were warned by megaphones to end the sit-in and to take a safe road to disperse by taking Al-Nasr Road and Al-Tayaran road reaching its intersection with Ramses Extension Street. The protestors were told through the megaphones that they would not be pursued by security forces, but they rejected these notifications.
- 2- Fire trucks were used to disperse protestors by using water cannons, and outlet routes were designated and announced through megaphones. Still, protestors refused to compel.
- 3- Loaders; alongside with anti-riot forces equipped with tear gas, shields, and helmets; were used to remove the barricades, blocks, and obstacles set in roads. The forces were surprised by intense attacks with bullets from different directions from the tops of buildings on Anwar Al-Mufti Street and from the top of Rab'a Mosque minaret, as well as from the top of a building under construction on Al-Tayaran Street. This resulted in the martyrdom of:

1- Lieutenant Mohamed Mohamed gouda Othman;

2- Captain Shady Magdi Abdul Gawwad Badr;

3- Captain Ashraf Mahmoud Fayed;

4- Lieutenant Mohamed Samir Ibrahim Abdul Mo'ty; and

5- Private Ibrahim Eid Al-Touny.

Other 46 policemen and police officers were injured by shotgun bullets and live ammunition. The assigned forces had to seek the assistance and support of additional forces trained to deal with shootings. There was exchange of fires between the forces and the protestors, which caused the death of a number of the protestors in Rab'a Square. Events escalated, and about 5000 of MB members gathered in front of the Nasr City Police Station building. They set fire to tires, blocked the road, and deliberately hindered public transportation and set fire to a number of cars. They burned the cars in the parking lot before the Police Station building and stole many cars and other fire trucks and cars that belonged to the Ministry of Interior, as well as the military fire truck no. 454935 for which a military misdemeanors report was filed. They also shot bullets at the Police Station and the forces assigned to secure its building, so there was an exchange of fires for over five hours. The following were arrested:

- 5- Abdul Hafeiz Mohamed Taqwa, 26, gatekeeper, residing in Dayrout, Asiut;
- 6- Sha'ban Said Ali Seddiq, 23, worker, residing at 30 Hamdi Mahmoud, Arab al-Tawayla, Al-Matareya;
- 7- Hossam Sedqi Mohamed Hussein, 49, worker, residing at 43 Al-Gamea Street, Gamal Abdul Nasser Street, Al-Salam;
- 8- Hossam Khaled Mohamed Mohiey El-Din, 37, marketing manager, residing at 1159, Zahraa, Nasr City;
- 9- Ahmed Tayea Mohamed Ahmed, born in 1976, Cooling technician, residing in Al-Haggana neighborhood, Nasr City;
- 10- Hamdi Mosadef Fetouh Eisa, born in 1976, worker, residing in Al-Ezba Al-Sharkeya, Al-Dab'a, Matrouh;
- 11- Mahmoud Mohamed Mahmoud Ibrahim, 33, holding a vocational high school diploma, residing in Al-Shawarga village, Abu Kbeer, Al-Sharqeya;
- 12- Mahmoud Gamal El-Din Mohamed, 27, employee, residing at 8 Awwal Mayo Street, Nasr City;
- 13- Mohamed Gad Mohamed Mohamed, 41, owner of a computer office, residing on Al-Omda Street, Ard Allewaa, Mohandiseen;
- 14- Yousef Mohamed Bayoumy Yousef, 33, residing on Ibrahim Al-Gazzar street, Al-Marg;
- 15- Hisham Abdeen Mohamed Abdeen, engineer, residing in Al-Haggana neighborhood, Nasr City;
- 16- Mahmoud El-Sayed Gad El-Sayed, 19, student, residing in Al-Mansheya El-Gedida, Faqous, Sharqeya;

- 17- Sherif Ramadan Ali Hassan, 33, driver, residing at 5 Hussein Ateya Street, Shubra Al-Kheima;
- 18- Mohamed Ali Hassan Ali, 48, School deputy principal, residing in Faqous, Sharqeya;
- 19- Mohamed El-Shafei Mustafa Abdullah, 26, tailor, residing in Matareya;
- 20- Karim Adel Abdullah Mohamed, 23, construction carpenter, residing at 3 Al-Sehha Street, Matareya;
- 21- Karim Mohamed Hassan Taha, 26, employee, residing at Block 10, Matareya;
- 22- Mohamed Mohamed Hafez Hassan, 28, worker, residing on Al-Kordy Street, Zaqaizeiq;
- 23- Mustafa Ali Abdulreheim, 21, woker, residing on Abdullah al-Araby Street, Matareya.

The aforementioned are accused of resisting authorities, arson and causing damage to private and public properties, attempted murder of policemen and officers and civilians in the streets, and causing injuries to them (including bruises and excoriations).
